AN ORDINANCE REPEALING ORDINANCE NO. 2010-19 REGULATING AND RESTRICTING THE PARKING OF MOTOR VEHICLES ON THE NORTH SIDE OF LEE STREET FROM THE CENTER OF THE INTERSECTION OF LEE STREET AND HALE STREET, EAST TO A POINT 155 FEET EAST OF THE CENTER OF SAID INTERSECTION OF LEE STREET AND HALE STREET, WITHIN THE CORPORATE LIMITS OF THE CITY OF PLANO, KENDALL COUNTY, ILLINOIS

WHEREAS, the City of Plano (hereinafter referred to as the "City") is an Illinois Municipal Corporation organized pursuant to the laws of the State of Illinois;

WHEREAS, the City has in full force and effect a codified set of ordinances which are of a general and permanent nature, which said codified set is known and designated as the City Code of the City of Plano, as amended;

WHEREAS, the City has the authority to adopt ordinances and to promulgate rules and regulations that pertain to its government and affairs that protect the health, safety and welfare of its residents including the adoption and imposition of certain taxes;

WHEREAS, the City continuously monitors and reviews its City Code to ensure that it is properly updated and revised to coincide with any current developments;

WHEREAS, public safety and convenience require that the parking of motor vehicles upon the public streets, thoroughfares, and parkways of the City of Plano be regulated; and

WHEREAS, the City Council of the City of Plano, Kendall County, Illinois, after study and investigation, has determined that the public safety and convenience requires that restrictions should be repealed as to the parking of motor vehicles within the corporate limits of the City of Plano, Kendall County, Illinois, to-wit: (A) The north side of Lee Street from center of the intersection of Lee Street and Hale Street, east to a point 155 feet east of the center of said intersection of Lee Street and Hale Street, in the City of Plano.

WHEREAS, The City had previously enacted parking restrictions on Lee Street pursuant to Ordinance No. 2010-19 which, in part, declared parking on the north side of Lee Street, from the center of the intersection of Lee Street and Hale Street, east to a point 155 feet east of the center of said intersection of Lee Street and Hale Street, to be illegal, and such regulation needs to be repealed.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of Plano, Kendall, Illinois in open meeting assembled as follows:

Section One – Recital

The Corporate Authorities hereby find that all of the recitals hereinbefore stated as contained in the preamble to this ordinance are full, true and correct and do hereby, by reference, incorporate and make them part of this ordinance as legislative findings.

Section Two – Recital

The following Section of the following street within the corporate limits within the City of Plano, Kendall County, Illinois, is herewith declared to be a valid parking zone to wit: (A) the north

side of Lee Street from the center of the intersection of Lee Street and Hale Street, east to a point 155 feet east of the center of said intersection of Lee Street and Hale Street, in the City of Plano.

Section Three

That the parking of motor vehicles on the portion of Lee Street as described hereof shall be and are herewith declared legal.

Section Four

That the No Parking regulation on Lee Street described above pursuant to Ordinance No. 2010-19 is hereby repealed.

Section Five

That the Superintendent of Streets of the City of Plano is herewith authorized to remove said street restricted parking signs bearing the following: "No Parking This Side of Street".

Section Six - Codification

The title, chapter(s) and section(s) adopted by this ordinance shall be numbered and placed in an appropriate title, chapter(s), and sections(s) sections when and during the codification of the Plano Municipal Code.

Section Seven - Conflict Clause

That all ordinances, parts of ordinances or board actions in conflict with the terms of this ordinance shall be repealed to the extent of said conflict.

Section Eight - Passage Clause

That this ordinance shall take full force and effect from and after its passage, approval and publication as provided by law.

Section Nine - Constitutionality Clause

Any part or parts of this ordinance declared by a court of law to be invalid or unconstitutional shall not affect the validity of the remaining provisions of this ordinance or the City of Plano Municipal Code.

Section Ten - Publication

This ordinance shall be published in book or pamphlet form as provided by the Illinois Municipal Code.

Section Eleven - Recording

This ordinance shall be entered into the minutes and upon the journals of the City Council of the City of Plano.

AN ORDINANCE AMENDING TITLE 3 CHAPTER 2 SECTION 3-2-7 OF THE CODE OF ORDINANCES OF THE CITY OF PLANO NUMBER OF CLASS G-1 LIQUOR LICENSES

WHEREAS, the City of Plano (hereinafter referred to as the "City") is an Illinois Municipal Corporation organized pursuant to the laws of the State of Illinois;

WHEREAS, the City has in full force and effect a codified set of ordinances which are of a general and permanent nature, which said codified set is known and designated as the City Code of the City of Plano, as amended;

WHEREAS, the City has the authority to adopt ordinances and to promulgate rules and regulations that pertain to its government and affairs that protect the health, safety and welfare of its residents including the adoption and imposition of certain taxes;

WHEREAS, the City continuously monitors and reviews its City Code to ensure that it is properly updated and revised to coincide with any current developments;

WHEREAS, the Corporate Authorities desire to amend its liquor code pertaining to the number of licenses available within a certain liquor code classification; and

WHEREAS, the Corporate Authorities of the City of Plano are of the opinion that that it is in the best interests of the safety, health and welfare of the residents to amend the portions of the City Code as set forth herein.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of Plano, Kendall, Illinois in open meeting assembled as follows:

Section One - Recitals

The Corporate Authorities hereby find that all of the recitals hereinbefore stated as contained in the preamble to this ordinance are full, true and correct and do hereby, by reference, incorporate and make them part of this ordinance as legislative findings.

Section Two – Amendment of Title 3 Chapter 2 Section 3-2-7(C)

Title 3 Chapter 2 Section 3-2-7(C) shall be and the same is hereby amended to decrease the number of Class G-1 Liquor License from six (6) to five (5).

Section Three – Codification

The title, chapter(s) and section(s) adopted by this ordinance shall be numbered and placed in an appropriate title, chapter(s), and sections(s) sections when and during the codification of the Plano Municipal Code.

Section Four - Conflict Clause

That all ordinances, parts of ordinances or board actions in conflict with the terms of this ordinance shall be repealed to the extent of said conflict.

Section Five – Passage Clause

That this ordinance shall take full force and effect from and after its passage, approval and publication as provided by law.

Section Six – Constitutionality Clause
